YOUR EXCELLENCY,

With reference to our last conversation, I am instructed by my Government, which is responsible for the conduct of the foreign affairs of Iceland, to inform you that the Government of Iceland agrees with the Government of the Austrian Federal Republic, that henceforward and pending a final arrangement, the provisions contained in the trade and shipping Convention, concluded on March 14, 1887, between Denmark and Austria-Hungary, should apply to the commercial relations between Iceland and Austria, with a modification to the effect that the period required for denunciation laid down in Article 6 of this Convention should be reduced to three months.

With reference to the two Notes which I have had the honour of addressing to you to-day in connection with the application to commercial relations between Denmark and Iceland and Austria of the provisions of the Commercial and Navigation Convention concluded on March 14, 1887, between Denmark and Austria-Hungary, I venture, in order that the matter should be made quite clear, and although the point in question is self-evident, to call your Excellency's attention—as I had the honour to do orally at our last meeting—to the fact that Austria cannot, in view of the relations established between Denmark and Iceland under the terms of the Danish-Icelandic Federal Law of November 30, 1918, claim for herself the privileges which Denmark has accorded, or may in the future accord, to Iceland, or which Iceland has accorded, or may in the future accord, to Denmark.
