YOUR EXCELLENCY,

Sofia, December 31, 1923.

I have the honour to confirm that an agreement has been reached between the Government of His Majesty the King of the Bulgarians and the Government of His Majesty the King of Sweden, for the regulation, as from September 12, 1923, of commercial and economic relations between the two countries on the basis of the mutual application of the most-favoured-nation clause.

It is understood that the provisions of the present Agreement shall not apply to the coasting trade nor to concessions which have been granted, or may be granted, by Bulgaria to Greece, to the Kingdom of the Serbs, Croats and Slovenes, to Roumania or to Turkey, and by Sweden to Norway or Denmark, provided that Bulgaria or Sweden, respectively, does not extend them to any other State.

The effects of the present Agreement shall not be suspended until three months after the day on which it has been denounced by one of the two Contracting Parties.

SWEDISH LEGATION.

Sofia, December 31, 1923.

YOUR EXCELLENCY,

I have the honour to confirm that an agreement has been reached between the Government of His Majesty the King of Sweden and the Government of His Majesty the King of the Bulgarians, for the regulation, as from September 12, 1923, of commercial and economic relations between the two countries on the basis of the mutual application of the most-favoured-nation clause.

It is understood that the provisions of the present Agreement shall not apply to the coasting trade nor to concessions which have been granted, or may be granted, by Sweden to Norway or Denmark and by Bulgaria to Greece, to the Kingdom of the Serbs, Croats and Slovenes, to Roumania or to Turkey, provided that Sweden or Bulgaria, respectively, does not extend them to any other State.

The effects of the present Agreement shall not be suspended until three months after the day

on which it has been denounced by one of the two Contracting Parties.
