No. 750. — EXCHANGE OF NOTES BETWEEN THE NORWEGIAN AND ROUMANIAN GOVERNMENTS CONSTITUTING AN ARRANGE-MENT FOR THE PROVISIONAL REGULATION OF COMMERCIAL RELATIONS BETWEEN NORWAY AND ROUMANIA. CHRISTIANIA, OCTOBER 1, 1924.

CHRISTIANIA, October 1, 1924.

Monsieur le Ministre.

In consequence of the denouncement of the Commercial Convention ² concluded between Norway and Roumania on March 31, 1910, that Convention ceased to have effect as from April 5, 1922.

Inasmuch as the Norwegian Government is desirous that the economic relations between the two countries should be developed, I am instructed to make the following proposal to the Royal Roumanian Government: namely, that the commercial relations between Norway and Roumania should be regulated by a provisional arrangement on the basis of the reciprocal application of the most-favoured-nation clause, the Contracting Parties being under the obligation to give three months' notice in the event of their wishing to denounce this arrangement.

If the Roumanian Government accedes to this proposal, the agreement between the two Governments might be regarded as being constituted by the present Note and by the reply which

you will be good enough to send me.

In so far as navigation is concerned, the Norwegian Government trusts that it may assume that Norwegian vessels will not be subjected, in Roumanian ports, to less favourable treatment than the vessels of any other State.

YOUR EXCELLENCY,

CHRISTIANIA, October 1, 1924.

In reply to the Note which you were good enough to address to me under to-day's date, I have the honour to inform you that the Royal Roumanian Government accedes to the Royal Norwegian Government's proposal: namely, that the commercial relations between Roumania and Norway should be regulated by a provisional arrangement on the basis of the reciprocal application of the most-favoured-nation clause, the Contracting Parties being under the obligation to give three months' notice in the event of their wishing to denounce this arrangement.

It is agreed that Norwegian vessels will not be subjected, in Roumanian ports, to less favourable

treatment than the vessels of any other State.
