YOUR EXCELLENCY,

BUDAPEST, March 31, 1925.

With reference to the Note Verbale No. 51337/1925 which was forwarded to the Polish Legation, under date March 18 last, by the Royal Hungarian Ministry for Foreign Affairs, I have the honour to inform Your Excellency that the Royal Hungarian Government is in agreement with the course proposed by the Polish Government in its Note Verbale No. 468/24 of August 13, 1924, and is quite willing that the question of the judicatum solvi security should be settled on the principle of reciprocity.

I have accordingly the honour to communicate the following declaration to Your Excellency

on behalf of the Royal Hungarian Government:

"Polish nationals who are plaintiffs or interveners in proceedings before Hungarian courts shall not be required to give security or to furnish a deposit of any description whatever, either on the ground that they are foreigners or that they do not possess a domicile or residence in the country, provided, however, that the Polish Government shall accord the same treatment to Hungarian nationals by virtue of a declaration in similar terms."

As soon as a declaration to that effect has been received from the Polish Government, the Royal Hungarian Government will see that it is communicated to the Hungarian Courts for their guidance.

YOUR EXCELLENCY,

With reference to the Note No. 57047/6 which you were good enough to send me, under date April 6 last, I have the honour to convey to you the following declaration by the Polish Government:

"Hungarian nationals who are plaintiffs (interveners) in proceedings before Polish courts shall not be required to give security or furnish a deposit of any description whatever, either on the ground that they are foreigners or that they do not possess a domicile or residence in the country."

I have the honour to request that Your Excellency will be good enough to have the above declaration communicated to the competent Hungarian courts and, at the same time, to send me an acknowledgment of the receipt of the present Note.
