ANGORA, March 15, 1927.

YOUR EXCELLENCY,

I have the honour to inform you that, pending the conclusion in the near future of a Treaty of Commerce and an Establishment Convention, the negotiations for which commenced on March 22, 1926, the Danish Government agrees that, as from April 1, 1927, agricultural and industrial products originating in and coming from Turkey which are imported into Danish territory and destined either for consumption or for re-exportation or transit, should receive most-favoured-nation treatment during a further period of six months.

It is agreed that the application of this provisional regulation is subject to the application in Turkey, during the same period, to agricultural and industrial products originating in and coming from Denmark, of the treatment laid down in the Commercial Convention signed at Lausanne on July 24, 1923, as regards the products of the States which signed that Convention.
