No. 1822. — EXCHANGE OF NOTES² BETWEEN THE EGYPTIAN AND HUNGARIAN GOVERNMENTS CONSTITUTING A PROVISIONAL COMMERCIAL AGREEMENT. CAIRO, FEBRUARY 16, 1927.

French official text communicated by the Chargé d'Affaires a. i. of the Royal Hungarian Delegation accredited to the League of Nations. The registration of this Exchange of Notes took place August 16, 1928.

CAIRO, February 16, 1927.

SIR,

With reference to the conversations between the Royal Hungarian Consulate-General for Egypt and this Ministry in regard to the conclusion of a Provisional Commercial Agreement between Hungary and Egypt, I have the honour to inform you that the Egyptian Government agrees to grant to all Hungarian products, leaf tobacco excepted, most-favoured-nation treatment, subject to perfect reciprocity and without prejudice to the treatment which is granted to Soudanese products or which may be applied under regional conventions to the products of certain coterminous countries.

This Agreement will come into force fifteen days after the exchange of the ratifications by the High Contracting Parties and may be denounced either by the Hungarian or by the Egyptian Government subject to three months' notice.

YOUR EXCELLENCY,

I have taken cognisance of the letter No. 7263/P, bearing to-day's date, which Your Excellency has addressed to me. The terms of the letter are as follows:

This Agreement will come into force fifteen days after the exchange of the ratifications by the High Contracting Parties and may be denounced either by the Hungarian or by the Egyptian Government subject to three months' notice.

In reply, I beg to confirm, in the name of my Government, my agreement with the terms cited.
