No. 1908. -- EXCHANGE OF NOTES BETWEEN THE HUNGARIAN AND LITHUANIAN GOVERNMENTS CONSTITUTING A PROVISIONAL COMMERCIAL AGREEMENT. KAUNAS, OCTOBER 23, 1928.

MONSIEUR LE MINISTRE.

KAUNAS, October 23, 1928.

I have the honour to inform you that the Hungarian Government, being desirous of promoting in every way the development of commercial relations between the Kingdom of Hungary and the Lithuanian Republic, will apply the following provisions to those relations pending the approaching conclusion of a regular commercial treaty.

- (1) Hungary undertakes to grant to Lithuanian products, subject to reciprocity, most-favoured-nation treatment in respect of importation, exportation and transit.
- (2) Nevertheless, Hungary shall not be entitled under the foregoing clause to claim the advantages which Lithuania has granted or may hereafter grant to Estonia or to Latvia, so long as the said advantages are not extended to a third State.

The present provisional Arrangement shall come into force as from to-day's date and shall remain in operation until the conclusion of a commercial treaty or until the expiry of a period of three months from the date of its denunciation by either of the Contracting Parties.

- (r) Lithuania undertakes to grant to Hungarian products, subject to reciprocity, most-favoured-nation treatment in respect of importation, exportation and transit.
- (2) Nevertheless, Hungary shall not be entitled under the foregoing clause to claim the advantages which Lithuania has granted or may hereafter grant to Estonia or to Latvia so long as the said advantages are not extended to a third State.

The present provisional Arrangement shall come into force as from to-day's date and shall remain in operation until the conclusion of a commercial treaty or until the expiry of a period of three months from the date of its denunciation by either of the Contracting Parties.
