No. 2496. — EXCHANGE OF NOTES BETWEEN THE PERSIAN AND SWISS GOVERNMENTS CONSTITUTING A PROVISIONAL SETTLEMENT OF THE RELATIONS BETWEEN THE TWO COUNTRIES. BERNE, MAY 28 AND AUGUST 28, 1928.

French official text communicated by the Permanent Delegate of Persia accredited to the League of Nations. The registration of this Exchange of Notes took place October 13, 1930.

BERNE, May 28, 1928.

SIR.

In view of the fact that circumstances prevent the rapid conclusion of a definitive commercial and establishment treaty between Switzerland and Persia, I have the honour on behalf of the Swiss Federal Council to make to you the following declaration constituting a provisional settlement of the relations between Switzerland and Persia:

r. Subject to full reciprocity, the diplomatic representatives of Persia on Swiss territory shall enjoy the privileges and immunities established by ordinary international law of nations. The consular representatives of Persia on Swiss territory, being duly provided with the exequatur, shall be entitled, subject to full reciprocity, to reside in places to which they have hitherto

They shall enjoy the honorary privileges, personal immunities from jurisdiction and taxation

established by the rules and practice of ordinary international law.

The treatment accorded to the diplomatic and consular representatives of Persia on Swiss territory, subject to reciprocity, shall not in any case be inferior to the treatment accorded to the diplomatic and consular representatives of any third country.

2. Subject to full reciprocity, Persian nationals shall continue to be admitted to Swiss territory and to be treated therein in accordance with the rules and practice of ordinary international law. They shall enjoy therein the fullest protection of the laws and authorities of Switzerland in respect of their persons and property, rights and interests. In general they shall enjoy in Swiss territory treatment which shall not in any case be inferior to the treatment accorded to the nationals of any third country.

In so far as their personal status in concerned, Persian nationals in Switzerland shall remain subject to the provisions of their national laws.

3. Subject to full reciprocity, articles produced or manufactured in Persia shall enjoy the Customs treatment provided by the laws in force at the time of their entry into Swiss territory, and shall have the benefit of the Swiss minimum tariff and of any reductions of that tariff which may be granted to similar products, natural or manufactured, originating in any other country.

The above provisions shall come into force immediately, and shall remain in force until the expiration of a period of thirty days from the notification by the Federal Council of its intention to terminate them.
