No. 2794. — PROTOCOL ² TO THE CONVENTION REGARDING EXTRADITION AND JUDICIAL ASSISTANCE IN CRIMINAL MATTERS, TO THE AGREEMENT REGARDING RECIPROCAL JUDICIAL ASSISTANCE IN CIVIL AND COMMERCIAL MATTERS, AND TO THE CONVENTION REGARDING THE RECOGNITION AND ENFORCEMENT OF JUDICIAL DECISIONS, CONCLUDED AT MADRID, ON NOVEMBER 26, 1927, BETWEEN THE KINGDOM OF SPAIN AND THE CZECHOSLOVAK REPUBLIC. SIGNED AT MADRID, AUGUST 13, 1928.

French official text communicated by the Permanent Delegate of the Czechoslovak Republic accredited to the League of Nations. The registration of this Protocol took place August 29, 1931.

The undersigned Plenipotentiaries, being duly authorised for the purpose, have agreed as follows:

I.

The provisions of the Convention³ on Extradition and Judicial Assistance in Criminal Matters, the Agreement⁴ concerning Reciprocal Judicial Assistance in Civil and Commercial Matters, and the Convention⁵ on the Recognition and Enforcement of Judicial Decisions, concluded between the Czechoslovak Republic and the Kingdom of Spain and signed on November 26, 1927, at Madrid, shall also apply to the territory of the Protectorate of the Kingdom of Spain in Morocco.

II.

The powers and duties accorded to the Ministry of Reprieve and Justice at Madrid defined in these Conventions ad in paragraph 2 of the Additional Protocol to the Agreement concerning Reciprocal Judicial Assistance in Civil and Commercial Matters, shall also be exercised by the High Commissariat of the Kingdom of Spain in Morocco.

III.

The list of Spanish administrative authorities annexed to the Agreement concerning Reciprocal Judicial Assistance in Civil and Commercial Matters, whose acts do not, according to Article 7, paragraph 2 of the Agreement, require any further legalisation to render them valid in judicial matters in the territory of the Czechoslovak Republic, shall include the High Commissariat of the Kingdom of Spain in Morocco.

IV.

The present Protocol shall be ratified and the ratifications shall be exchanged at Prague at the same time as the ratifications of the above-mentioned Conventions and Agreement.

Done at Madrid in duplicate on the thirteenth day of August, one thousand nine hundred and twenty-eight.
