ITALY AND PERSIA

Treaty of Friendship with Final
Protocol. Signed at Teheran,
September 5, 1929.

¹ TRADUCTION. — TRANSLATION.No. 3264. — TREATY ² OF FRIENDSHIP BETWEEN THE KINGDOM OF ITALY AND THE PERSIAN EMPIRE. SIGNED AT TEHERAN, SEPTEMBER 5, 1929.

French official text communicated by the Italian Minister for Foreign Affairs. The registration of this Treaty took place September 12, 1933.

HIS MAJESTY THE KING OF ITALY and HIS IMPERIAL MAJESTY THE SHAH OF PERSIA, being equally desirous of consolidating the traditional relations of friendship between the two States, have decided to conclude a Treaty of Friendship and have for this purpose appointed as their Plenipotentiaries :

HIS MAJESTY THE KING OF ITALY :

M. Giulio DANE0, His Envoy Extraordinary and Minister Plenipotentiary at Teheran ;

HIS IMPERIAL MAJESTY THE SHAH OF PERSIA :

His Highness MEHDI Gholi Khan Hedayat, His President of the Council of Ministers ;

Who, having communicated their full powers found in due and good form, have agreed upon the following provisions.

Article 1.

There shall be inviolable peace and sincere and perpetual friendship between the Kingdom of Italy and the Persian Empire as well as between the nationals of the two States.

Article 2.

The Contracting States agree to continue their diplomatic and consular relations in conformity with the principles and practice of common international law. They agree that the diplomatic and consular representatives of each of them shall in the territory of the other receive the treatment recognised by the principles and practice of common international law ; in any case, and on conditions of reciprocity, this treatment shall not be less favourable than that accorded to the diplomatic and consular representatives of the most-favoured-nation.

Article 3.

The High Contracting Parties agree to submit to procedures of pacific settlement any dispute which may arise between them which it has not been possible to settle amicably within a reasonable

period by the normal methods of diplomacy. They reserve the right to decide in each case by a special agreement the procedure which seems to them the most suitable.

They agree further that, if they should both accede to a general formula recommended by the League of Nations, they would apply this formula to the settlement of all disputes to which it was adapted in derogation, if necessary, of the foregoing provisions.

Article 4.

The present Treaty shall be ratified and the ratifications shall be exchanged as soon as possible. It shall come into force on the exchange of ratifications.

In Faith whereof the respective Plenipotentiaries, duly authorised for this purpose, have signed the present Treaty and have thereto affixed their seals.

Done at Teheran the fifth day of September, nineteen hundred and twenty-nine.

FINAL PROTOCOL.

On proceeding to sign the Treaty of Friendship concluded to-day between the Kingdom of Italy and the Persian Empire, the undersigned Plenipotentiaries have made the following declaration which shall form an integral part of the Treaty :

The two Contracting States reserve the right to re-examine the provisions of Article 3 of the Treaty of Friendship ten years after the exchange of ratifications of the said Treaty.

Done at Teheran on the fifth day of September, nineteen hundred and twenty-nine.
