No. 3573. — CONVENTION ² BETWEEN THE ARGENTINE REPUBLIC AND SWEDEN CONCERNING COMPENSATION FOR INDUSTRIAL ACCIDENTS. SIGNED AT BUENOS AIRES, MAY 14TH, 1928.

French official text communicated by the Swedish Minister for Foreign Affairs and by the Minister for Foreign Affairs of the Argentine Republic. The registration of this Convention took place January 1st, 1935.

HIS EXCELLENCY THE PRESIDENT OF THE ARGENTINE NATION and HIS MAJESTY THE KING OF SWEDEN, being desirous, by an arrangement concerning compensation for industrial accidents, of regulating the treatment of workers of both countries who meet with industrial accidents in their respective territories, and of securing for them the benefits of reciprocity in respect of the compensation to which they are entitled, have appointed as their Plenipotentiaries:

HIS EXCELLENCY THE PRESIDENT OF THE ARGENTINE NATION:

His Excellency the Minister for Foreign Affairs and Public Worship, Dr. Angel Gallardo; His Majesty the King of Sweden:

His Excellency Monsieur Eric Einar Ekstrand, Envoy Extraordinary and Minister Plenipotentiary to the Argentine Government;

Who, having exchanged their full powers, found in good and due form, have agreed as follows:

Article 1.

Subjects of the Argentine Republic who meet with industrial accidents in Sweden, and their surviving dependants, shall be entitled to the compensation and other rights granted to Swedish subjects by the laws in force respecting compensation for industrial accidents.

Reciprocally, Swedish subjects who meet with industrial accidents in the territory of the Argentine Republic, and their surviving dependants, shall be entitled to the compensation and other rights granted to Argentine subjects by the laws in force respecting liability for industrial accidents.

Article 2.

The above stipulation as to reciprocity shall apply even to cases where injured persons or their dependants leave the territory of Sweden or of the Argentine Republic, as the case may be, at a date subsequent to the accident. The same rule shall apply to cases where the dependants are not resident in the country where the accident occurred.

Article 3.

This Convention shall be ratified and the instruments of ratification shall be exchanged at Buenos Aires as soon as possible.

It shall come into force in the Argentine Republic and in Sweden one month after its publication

in both countries in the manner prescribed by their respective laws.

It shall remain binding until the expiration of a period of six months reckoned from the date of its denunciation by either of the Contracting Parties.

In faith whereof the Plenipotentiaries appointed for this purpose have affixed their signature and their seal to the present Convention, drawn up in French in two copies at Buenos Aires, capital of the Argentine Republic, on this 14th day of May, of the year 1928.
