LE GOUVERNEMENT NATIONAL DE LA RÉPUBLIQUE CHINOISE et LE GOUVERNEMENT DE LA RÉPUBLIQUE FRANÇAISE, animés du désir de resserrer les liens d'amitié qui existent heureusement entre les deux pays et en vue de développer les relations commerciales entre la Chine et l'Indochine française, ont décidé de conclure une nouvelle convention et ont, à cet effet, nommé leurs plénipotentiaires respectifs, à savoir :

Son Excellence le Dr Chengting T. Wang, ministre des Affaires étrangères du Gouvernement national de la République chinoise ;

LE Président de la République française :

Son Excellence le comte de Martel, ambassadeur, ministre plénipotentiaire et envoyé extraordinaire de la République française en Chine, commandeur de la Légion d'honneur:

Lesquels, après s'être communiqué leurs pleins pouvoirs, trouvés en bonne et due forme, sont convenus des articles suivants :

Article premier.

La Convention² de commerce sino-française de Tientsin du 25 avril 1886 (vingt-deuxième jour de la troisième lune de la douzième année de Kouang-Hsu), la Convention² commerciale additionnelle signée à Pékin le 26 juin 1887 (sixième jour de la cinquième lune de la treizième année de Kouang-Hsu), ainsi que les lettres officielles relatives à cette convention échangées à Pékin le

23 juin 1887 (troisième jour de la cinquième lune de la treizième année de Kouang-Hsu) et la Convention complémentaire signée à Pékin le 20 juin 1895 (vingt-huitième jour de la cinquième lune de la vingt et unième année de Kouang-Hsu) sont abrogées et cessent de produire leurs effets.

Les stipulations des articles 4, 5 et 6 du Traité 2 de Tientsin du 9 juin 1885 (vingt-septième jour de la quatrième lune de la onzième année de Kouang-Hsu) sont également abrogées.

Article II.

La ville de Long-tchéou au Kouangsi, celles de Sse-Mao, de Ho-K'éou et de Mong-Tseu au Yunnan demeurent ouvertes au commerce à travers la frontière terrestre de la Chine et de l'Indochine française.

Article III.

Le Gouvernement chinois pourra envoyer des consuls en Indochine française dans les villes de Hanoï ou de Haïphong et de Saïgon et le Gouvernement français pourra continuer d'envoyer des consuls dans les localités mentionnées à l'article précédent.

Les chefs et gérants des consulats et vice-consulats ainsi que les agents des services consulaires devront être nationaux du pays qui les nomme. Ils ne pourront exercer ni commerce ni industrie.

Article IV.

Les ressortissants chinois à leur entrée sur le territoire de l'Indochine française et les ressortissants français d'Indochine à leur entrée sur le territoire de la Chine, devront être munis de passeports délivrés par les autorités compétentes de leur pays d'origine. Ces passeports devront être visés par un consulat du pays de destination ou par les autorités dudit pays qualifiées à cet effet.

Les Hautes Parties contractantes s'engagent à s'accorder mutuellement, en se conformant à leurs lois et règlements respectifs, le traitement de la nation la plus favorisée pour ce qui concerne

l'accomplissement des formalités y compris celles de l'identification relatives :

- 10 Aux passeports;
- 2º Au régime des laissez-passer intérieurs et des visas de sortie ;
- 3º A l'entrée et à la sortie des ressortissants français d'Indochine et des ressortissants chinois se rendant en Indochine ou dans les trois provinces du Yunnan, du Kouangsi et du Kouangtong.

Il n'est rien modifié au régime des passes temporaires ou permanentes délivrées aux habitants des zones frontières qui seraient appelés par leurs travaux ou par leurs affaires à séjourner temporairement ou à se rendre fréquemment sur le territoire de l'autre pays au voisinage de la frontière.

Article V.

Les ressortissants chinois en Indochine française et les ressortissants français dans les localités chinoises susmentionnées, auront le droit de résider, de voyager, de se livrer au commerce ou à l'industrie. Le traitement qui leur sera accordé pour l'exercice de ces droits conformément aux règlements et lois en vigueur soit en Indochine française, soit en Chine, ne devra en aucun manière être moins favorable que celui des ressortissants de toute autre Puissance.

Les ressortissants chinois en Indochine française et les ressortissants français dans les localités chinoises déterminées ci-dessus ne pourront être assujettis à des impôts, taxes ou contributions autres ou plus élevés que ceux auxquels pourraient être soumis les ressortissants de la nation la

plus favorisée.

de reviser ou de dénoncer la présente convention ; celle-ci continuera de s'appliquer si pareille notification n'est pas effectuée dans le délai prévu ci-dessus, étant bien entendu que chacune des Hautes Parties contractantes pourra à tout moment, après l'expiration de la période susmentionnée de cinq ans, notifier à l'autre son intention de reviser ou de dénoncer la présente convention qui deviendra nulle et inopérante un an après le jour de cette notification.

La présente convention avec ses annexes sera ratifiée aussitôt que possible et l'échange des ratifications aura lieu à Paris. Elle sera promulguée en Indochine et y entrera en vigueur en même temps que dans les trois provinces du Yunnan, du Kouangsi et du Kouangtong deux mois après

l'échange des ratifications.

Article XI.

La présente convention a été rédigée en chinois et en français, les deux textes ayant été soigneusement comparés et vérifiés.

En foi de quoi les plénipotentiaires respectifs ont signé la présente convention en double exemplaire et y ont apposé leurs sceaux.

No. 3738. — CONVENTION CONCERNING THE RELATIONS BETWEEN CHINA AND FRANCE WITH REGARD TO FRENCH INDO-CHINA AND THE ADJACENT CHINESE PROVINCES. SIGNED AT NAN-KING, MAY 16TH, 1930.

THE NATIONAL GOVERNMENT OF THE REPUBLIC OF CHINA and THE GOVERNMENT OF THE FRENCH REPUBLIC, being desirous of strengthening the ties of friendship which happily exist between the two countries, and in order to develop commercial relations between China and French Indo-China, have decided to conclude a new Convention and have accordingly appointed as their respective Plenipotentiaries:

THE PRESIDENT OF THE NATIONAL GOVERNMENT OF THE REPUBLIC OF CHINA:

His Excellency Dr. Chengting T. WANG, Minister for Foreign Affairs of the National Government of the Republic of China:

THE PRESIDENT OF THE FRENCH REPUBLIC:

His Excellency Count DE MARTEL, Ambassador, Minister Plenipotentiary and Envoy Extraordinary of the French Republic in China, Commander of the Legion of Honour:

Who, having communicated their full powers, found in good and due form, have agreed on the following Articles:

Article I.

The Sino-French Commercial Convention of Tientsin, dated April 25th, 1886 (twenty-second day of the third moon of the twelfth year of Kwang-Hsu), the additional Commercial Convention signed at Pekin on June 26th, 1887 (sixth day of the fifth moon of the thirteenth year of Kwang-Hsu), and the official letters regarding this Convention exchanged at Pekin on June 23rd, 1887 (third day of the fifth moon of the thirteenth year of Kwang-Hsu), and the Supplementary Convention signed at Pekin on June 20th, 1895 (twenty-eighth day of the fifth moon of the twenty-first year

of Kwang-Hsu), are abrogated and shall cease to have effect.

The stipulations of Articles 4, 5 and 6 of the Treaty of Tientsin of June 9th, 1885 (twenty-seventh day of the fourth moon of the eleventh year of Kwang-Hsu), are also abrogated.

Article II.

The town of Lung-Chow in Kwangsi and those of Sze-Mao, Hokow and Mong-Chu in Yunnan shall remain open to commerce across the land frontier of China and French Indo-China.

Article III.

The Chinese Government may send consuls to French Indo-China in the towns of Hanoi, Haiphong and Saigon, and the French Government may continue to send consuls to the localities mentioned in the previous Article.

The heads and administrators of consulates and vice-consulates and the agents of the consular services must be nationals of the country which appoints them. They may not engage in trade or industry.

Article IV.

Chinese nationals on entering the territory of French Indo-China, and French nationals of Indo-China on entering the territory of China, must be provided with passports issued by the competent authorities of their country of origin. These passports must be endorsed by a consul of the country of destination or by the authorities of the said country qualified for this purpose.

The High Contracting Parties undertake to grant each other, in conformity with their respective laws and regulations, most-favoured-nation treatment as regards the performance of

formalities, including those of identification, concerning:

- (1) Passports;
- (2) The regime of internal passes and exit visas;
- (3) The entrance and exit of French nationals of Indo-China and Chinese nationals proceeding to Indo-China or to the three provinces of Yunnan, Kwangsi and Kwangtung.

No change shall be made in the regime of temporary or permanent passes issued to inhabitants of the frontier zones who may be obliged by their work or business to stay temporarily in or proceed frequently to the territory of the other country in the neighbourhood of the frontier.

Article V.

Chinese nationals in French Indo-China and French nationals in the Chinese localities mentioned above shall have the right to reside, travel and engage in trade or industry. The treatment granted them for the exercise of these rights in accordance with the regulations and laws in force both in French Indo-China and in China shall in no respect be less favourable than that of the nationals of any other Power.

Chinese nationals in French Indo-China and French nationals in the Chinese localities mentioned above may not be subjected to imposts, taxes or contributions other or higher than those levied

on the nationals of the most-favoured nation.

Article VI.

Chinese goods coming from any Chinese port and conveyed direct or under a through way-bill to the provinces of Yunnan, Kwangsi and Kwangtung through the territory of Tongking shall enjoy preferential treatment and shall not be subject to the transit duty of the general tariff.

They shall only pay a duty of I % ad valorem.

Similarly, Chinese goods from the provinces of Yunnan, Kwangsi and Kwangtung passing through the territory of Tongking for any other authorised destination shall enjoy preferential treatment and shall not be subject to the transit duty of the general tariff.

Ores of all kinds, pig tin, raw hides and the goods already contained or inserted hereafter in List A annexed to the present Convention shall enjoy exemption from all duties. Other goods

shall pay a duty of I % ad valorem.

War material, arms and ammunition which the National Government may desire to send in

transit through the territory of Tongking shall be exempt from all duties.

Indo-Chinese vessels, with the exception of warships and vessels employed for the transport of troops, arms and munitions of war, may travel from Langson to Kaobang and vice versa, using the rivers Song-Ki-Kong and Song-Bang-Kiang which connect Langson with Lung-Chow and Kaobang.

These vessels and the goods which they carry in transit shall have no duty to pay on entering

China.

Article VII.

The two Governments respectively undertake not to impose any prohibition or restriction on imports, exports or transit in Indo-China and in the three provinces of Yunnan, Kwangsi and Kwangtung which is not immediately applicable to other Powers.

The two Governments nevertheless reserve the right to enact in regard to all products coming from or consigned to either country such prohibitions or restrictions on importation, exportation or transit as may be necessitated by reasons of national defence, food supply, the protection of artistic and scientific wealth, the prevention of epidemics and epizootics, the protection of crops, State monopolies and public morality, on the understanding that these measures are justified by absolute necessity and shall apply to all countries in similar circumstances.

Article VIII.

The Chinese Government in the provinces of Yunnan, Kwangsi and Kwangtung, and the French Government in the territory of French Indo-China, shall not on any pretext levy on goods imported or exported by French or Chinese nationals, respectively, excise duties or internal taxes other or higher than those imposed on their own nationals or on nationals of any other Power.

Article IX.

Chinese nationals guilty or accused of crimes or offences committed in China who may seek refuge in the territory of French Indo-China, and French nationals guilty or accused of crimes or offences committed in Indo-China who may seek refuge in the territory of China, shall, at the request of the authorities concerned and on proof of their guilt, be sought out, arrested and extradited, it being understood that an exception shall be made in all cases which, in accordance with international usage, do not give rise to extradition.

Article X.

The present Convention is concluded for a period of five years. Six months before the expiration of the said period, each of the High Contracting Parties may notify the other of its intention to revise or denounce the present Convention; the latter shall continue to apply if such notification has not been made within the period stipulated above, it being understood that each of the High Contracting Parties may at any time after the expiration of the above-mentioned period of five years notify the other of its intention to revise or denounce the present Convention, which shall become null and void one year after the date of such notification.

The present Convention with its Annexes shall be ratified as soon as possible and the exchange of ratifications shall take place in Paris. It shall be promulgated in Indo-China and shall enter into force at the same time as in the three provinces of Yunnan, Kwangsi and Kwangtung, two

months after the exchange of ratifications.

Article XI.

The present Convention has been drawn up in Chinese and French, the two texts having been carefully compared and verified.

In faith whereof the respective Plenipotentiaries have signed the present Convention in duplicate and have thereto affixed their seals.

Done at Nanking on the sixteenth day of the fifth month of the nineteenth year of the Republic of China, corresponding to May 16th, 1930.

YOUR EXCELLENCY,

With reference to Article VIII of the Convention which we have signed on to-day's date, I have the honour to confirm that, with a view to developing trade between China and French Indo-China, the Chinese goods coming from Yunnan, Kwangsi and Kwangtung enumerated in List A attached, and the articles appearing in the list attached to the Sino-French Customs Treaty of December 22nd, 1928, shall enjoy the minimum tariff on their entry into French Indo-China, when they are conveyed direct or with a through way-bill.

They shall enjoy this tariff as long as the duties of the Chinese national tariff of 1929 are not increased with regard to the French and Indo-Chinese goods exported from French Indo-China direct or with a through way-bill to Yunnan, Kwangsi and Kwangtung, enumerated in the attached

"They shall enjoy this tariff as long as the duties of the Chinese national tariff of 1929 are not increased with regard to the French and Indo-Chinese goods exported from French Indo-China direct or with a through way-bill to Yunnan, Kwangsi and Kwangtung, enumerated in the attached List B."

EXCHANGES OF NOTES.

NANKING, September 2nd, 1933.

YOUR EXCELLENCY.

The Chinese Government has recently increased the import duties of the Customs tariff on

coal, including Indo-Chinese anthracite.

I venture to remind you that in the course of our recent conversations it was understood that anthracite coal coming from Indo-China — on the definition of which we agreed — would be entered in List B provided for in the Convention of May 16th, 1930, and that the duty to be levied on the importation of this article would not be greater than that of the tariff in force in 1932, namely C. G. U. 0.89 per ton.

You will realise that an increase in the said tariff would be likely to hamper most seriously the progress of the present negotiations, and that it would be difficult for us to reach the agreement

desired by our two Governments on Lists A and B.

In these circumstances, I have the honour to request you to confirm that when the agreement on the two lists has been signed, and on the date of the putting into force of the Convention, the import duty on anthracite coal, *i. e.* on coal with a fuel ratio of 5 or over, will not exceed C. G. U. o.89 per ton.

In reply, I have the honour to inform you that when the agreement on the two lists at present under negotiation has been signed, and on the date of the putting into force of the Convention, the duty on the importation of anthracite coal, $i.\ e.$ of coal with a fuel ratio of 5 or over, will not exceed C. G. U. 0.89 per ton.

PROTOCOL ESTABLISHING LISTS A AND B.

PROTOCOL.

In accordance with the provisions laid down in the letters exchanged:

- (1) On May 16th, 1930, between the Minister for Foreign Affairs of the Chinese Republic and the Minister Plenipotentiary and Envoy Extraordinary of the French Republic in China, and attached to the Convention of the same date, regulating the relations between France and China in connection with French Indo-China and the adjacent Chinese provinces;
- (2) On September 2nd and 5th, 1933, between the Minister for Foreign Affairs of the Chinese Republic and the Minister Plenipotentiary and Envoy Extraordinary of the French Republic in China, concerning the duty to be levied on the importation of anthracite coal from Indo-China;
- (3) On May 4th, 1935, between the Minister for Foreign Affairs of the Chinese Republic and the Minister Plenipotentiary and Envoy Extraordinary of the French Republic in China, substituting, as regards the first five items of List B, the Chinese national tariff at present in force for that of the year 1929.

Lists A and B have been fixed as follows:

The Chinese goods enumerated in List A shall enjoy the minimum tariff on entry into French Indo-China as long as the duties in the Chinese national tariff at present in force are not increased as regards the first five articles mentioned below, and as long as the duty applied to the last article as fixed in the letter of September 5th, 1933, from the Minister for Foreign Affairs to the French Minister has not been modified, it being understood that these articles originating either in France or French Indo-China shall be exported from Indo-China to Yunnan, Kwangsi and Kwangtung direct or with a through way-bill:

DECLARATION.

The Chinese Government declares that it will take no measures aimed at prohibiting the importation of rice from French Indo-China to the provinces of Yunnan, Kwangsi and Kwangtung, or to restrict the quantities thereof to be imported. This Declaration is valid for a duration of two years as from the putting into force of the Convention of May 16th, 1930. After this period it may only be denounced at three months' notice.

The import duty on Indo-Chinese rice exported from French Indo-China to the three provinces mentioned above shall be C. G. U. 1.50 per 100 kg. and for a period of two years only as from the date of the putting into force of the Convention of May 16th, 1930.

The Chinese Government also declares that it will not apply to rice, cement and dried and salted fish from French Indo-China import duties higher than those levied on similar products originating

in any other country.
