No. 4101. — EXCHANGE OF NOTES 2 BETWEEN THE BELGIAN AND NORWEGIAN GOVERNMENTS CONSTITUTING AN AGREEMENT REGARDING THE LEGALISATION OF CERTIFICATES OF ORIGIN FOR GOODS TO BE EXPORTED FROM NORWAY TO BELGIUM. BRUSSELS, MARCH 10TH, 1937.

YOUR EXCELLENCY.

With reference to my conversations at the Ministry of Foreign Affairs and Foreign Trade regarding the legalisation of certificates of origin to be presented to the Belgo-Luxemburg Clearing Office in respect of Norwegian goods consigned to the territory of the Economic Union of Belgium and Luxemburg, I have the honour, on instructions from my Government, to propose to the Belgian Government the conclusion of an Agreement based on the following principles:

The Belgian Government shall agree to entrust the endorsement of certificates of origin to be presented to the Belgo-Luxemburg Clearing Office to the Norwegian Customs Service, jointly with the Belgian consular authorities, subject to the following conditions:

- (x) The certificates in question shall apply exclusively to goods manufactured, grown or extracted in Norwegian territory;
- (2) The said certificates shall conform to the model annexed hereto and shall be made out, not on a separate sheet but on the invoice itself, the back being used if there is no room on the front.

Enclosed Your Excellency will find a model of the certificates and endorsements in question.

The present Agreement shall come into force on March 15th, 1937.

MONSIEUR LE CHARGÉ D'AFFAIRES.

You were good enough to inform me of the Norwegian Government's proposals for the conclusion of an agreement for the issue by the Norwegian Customs Service, jointly with the Belgian consular authorities, of certificates of origin relating to goods intended for export from Norway to Belgium. In consequence, I have the honour to inform you that the Royal Belgian Government agrees to the conclusion of an Agreement based on the following principles:

- (1) The certificates of origin shall apply exclusively to goods manufactured, grown or extracted in Norwegian territory;
- (2) The said certificates shall conform to the model annexed hereto and shall be made out, not on a separate sheet but on the invoice itself, the back being used if there is no room on the front.

The present Agreement shall come into force on March 15th, 1937.
