Monsieur le Ministre,

By a letter dated April 25th, 1934, A. 4. No. 1910, the late Monsieur Maskens had the honour to enquire of your predecessor whether the Queen's Government had any objection to the service of judicial and extrajudicial documents to persons in the Netherlands being effected, where appropriate, directly through a Netherlands process-server, in accordance with Article 6 (2) of the International Convention relating to Civil Procedure signed at The Hague on July 17th, 1905.

In a communication dated July 19th, 1934, No. 23844, His Excellency Jonkheer de Graeff stated that, subject to reciprocity, the Queen's Government had no objection to such a procedure.

I have the honour to inform Your Excellency that the King's Government agrees with the Netherlands Government to permit, subject to reciprocity, the service of judicial and extrajudicial documents, in their respective countries, to be effected directly through the competent process-servers, in conformity with the right laid down in the said Article of the Hague Convention.

I have been instructed to propose to Your Excellency that this letter and that of Your Excellency acknowledging its receipt should be considered as evidence of the Agreement reached in this matter, and that the said Agreement should come into force a month after the date of the Netherlands authorities' acknowledgment of receipt.

I avail myself of this opportunity, etc.
